Applying to more than one RRB by a candidate will result in the rejection of all applications. 12.0 Eligibility: Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his / her
